NOTICE is hereby given that Somerset County Council proposes to make the above Order in pursuance of the provisions of the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce a 50mph speed limit and 40mph speed limit on the lengths of road as specified in Schedules 1 and 2 to this Notice.

Sedgemoor District Council, The Sedgemoor District Council (A370 Lympsham) (50mph Speed Limit) Order 1995 is hereby revoked as specified in Schedule 3 to this Notice.
